

CITY OF MEMPHIS SEWER SYSTEM



- Over 2,800 miles of Sanitary Sewer Lines
- 85,000 manholes
- 102 lift stations /300+ siphons
- 2 treatment plants (T.E.
 Maxson & Maynard C. Stiles) 150 mgd average daily flow

SARP10 Program

- General Requirements:
 - Reduce SSOs and backups
 - Assessment of the entire Wastewater Collection & Transmission System
 - Conduct Assessment of approximately 250 Miles annually
 - Rehabilitate priority areas and sewers
 - Enhance preventive maintenance
 - Rehabilitate assets in accordance with IRP
- 10 year program: CD executed September 20th, 2012.




Scope of Work

- Completion and correct documentation per Technical Specifications of the condition assessment of sanitary sewer lines and manholes
- There are five contracts:
 - 78.0126: North Whitehaven (NS01, NS03,& NS04)
 - 78.0127: Hurricane Creek (NS05-1 & NS06)
 - 78.0128: Tenmile Creek-Southwind (NS07-2, NS09-3, & NN09)
 - 78.0129: Wolf River Interceptor (woo5, woo6, woo7, & woo8)
 - 78.0130: IRP Reassessment 2021
- All areas include small and large diameter CCTV/sonar with cleaning, smoke testing, manhole inspections, and 3D manhole inspections for large diameter lines.






VICINITY MAPS



TEAMWORX

- Tool that is used in the field to track work sites and report issues
- Crews will be responsible for updating their work sites as they change throughout the day
- Can be used on a smartphone or a computer
- Allows mobile access to Program's Sewer GIS
- Individual training classes will be established to train new contractors on usage

DATA



Conduct Inspections

Deliver Weekly Submittal

Data Delivery Schedule

- Submittals are due Monday a week after work is completed
- Submittal Rejections- Due seven (7) days after notice
- Technical Rejections- Due fourteen (14) calendar days after notice is received.
- What is provided in the submittal is what is processed.
- The program will track when inspections are completed in the field and will if any are overdue
