Quarterly Report

Third Quarter 2015

On September 20, 2012, the United States District Court for the Western District of Tennessee entered a Consent Decree between the City of Memphis and the United States, the State of Tennessee, and the Tennessee Clean Water Network.

To fulfill the reporting requirements defined in Section VIII.24 of the Consent Decree, the City of Memphis has prepared this Quarterly Report, which summarizes all SSO events occurring from July 1 through September 30, 2015. The table included in this report provides the date, time, location, source, estimated duration, estimated volume, receiving water (if any), and cause of the SSO event. An "SSO event" means the total time period SSOs occur at the same location and due to the same cause(s).

In accordance with Appendix J of the Consent Decree, the City of Memphis submitted the finalized Color Study report entitled, *Perception studies to determine receiving-stream color objectionability due to effluent discharge*, to TDEC on October 29, 2014 following its review of the initial study results with TDEC personnel during a meeting held at TDEC's office in Nashville, Tennessee, on July 10, 2014. In light of TDEC's May 19, 2015, letter to the City regarding the Color Study, further discussion with TDEC is necessary regarding the finality of the study and the trigger for submission of the State Project Completion Report. Pending resolution, the City (who has already expended more than the \$645,000 required by the CD) intends to submit the State Project Completion Report.
