Mandatory Pre-Bid Meeting Notes and Sign-In Sheet

Q1: When releasing manholes in groups of ten to the contractor, will they be in the same general area? **SARP10:** We issue them as we get them in from SSES assessment contractors. We make an effort to issue them in the same geographic area, but there is no guarantee that this will be the case.

Q2: On unit prices, removal & replacement is two separate line items. What is the reason? **SARP10:** Earlier projects found that in some cases, significant quantities of paving removal were required, but there is a maximum replacement depth in the details. The change better delineates the scope of the pay items.

Q3: How do we control/prevent duplicate manhole inspections between the SSES contractor and manhole adjustment contractor?

SARP10: Completing MACP inspection shortly after the adjustment is completed and submitting for review is the best way to prevent duplication. Refer to CityWorks for the most up-to-date inspection information. If there is doubt about a facility's inspection status, communicate with the SSES contractor or the SARP10 team for clarification.

Q4: Will any maps be given to the contractor?

SARP10: No, but the contractor will have access to CityWorks, which has the most up to date information.
