The following information encompasses Addendum # 1 for the above referenced RFB. Bidders shall fully consider and acknowledge this Addendum in the preparation and submittal of its formal Bid. Failure to do so may result in the rejection of the Bid.

**Please note that questions submitted via email not addressed in this addendum will be addressed in a subsequent Addendum, with the Final Addendum to be issued by Tuesday, May 16, 2017.

All other conditions and requirements remain unchanged.

Section 1 – Bidder Questions

Q1: What is the required depth of hydro excavation?

SARP10: 4 feet.

Q2: What defines the perimeter of the excavation?

SARP10: The Subcontractor is responsible for marking the perimeter of the excavation before utility locates are called.

Q3: Is the Subcontractor responsible for verifying the location of the defect where the point repair will occur?

SARP10: The Subcontractor will be given the CCTV log of the line obtained when SARP10 performed inspections of the area which will include the approximate location of the defect. The Subcontractor is responsible for verifying the location by whatever means he/she deems necessary. No additional payment will be made for excavations made at the wrong location.

Q4: If a DBE firm is on the City list, can one firm meet the SRF goals? For example, would it suffice for the Subcontractor to use only a WBE firm if they meet the 15% requirement.

SARP10: No. The Subcontractor must meet the 2.6% MBE *and* the 2.6% WBE to meet SRF requirements.

Q5: How long does the Subcontractor have to complete the post point repair inspection?

SARP10: All work associated with a particular point repair must be completed within the 30 day timeframe as outlined in the RFB unless directed otherwise by SARP10.

Q6: Is the post-inspection CCTV log covered under a line item?

SARP10: Yes, post-inspection CCTV is covered under line item 00003-6.01 and must meet NASSCO PACP requirements. Any inspection done before the repair is at the Subcontractor's expense and is not required to be submitted.

Q7: Can SARP10 provide a list of approved Subcontractors?

SARP10: Yes, a list will be provided in a separate addendum.

Q8: Can the Subcontractor use a tripod for fall protection?

SARP10: A tripod can be used as fall protection for employees accessing the manhole but the Subcontractor is also required to use either a cage or a star over the manhole for fall protection whenever the manhole is open.

Q9: Is the time required to properly locate underground utilities included in the 30 days to complete the repair?

SARP10: Yes unless unforeseen circumstances occur and SARP10 approves an extension.

Q10: Are Subcontractors required to take the People Matter Most training as well as safety orientation?

SARP10: Yes, all personnel on the program are required to do both.

Q11: How will the depth be measured for the point repair?

SARP10: The depth will be measured from the ground surface to the invert of the pipe.

Contractor Qualification

All contractors are required to pre-qualify for work on the SARP10 program, before a contract is issued or work can begin. There are two levels Prime and Sub-Contractor. Prime is a contractor who will contract direct to SARP10 and have others working for them. Sub is any company working on the program for companies other than us. All contractors are looked at on an individual basis, if you have any concerns please contact me. We have helped numerous contractors through our approval process.
