In conjunction with the City's Consent Decree Sewer Assessment and Rehabilitation Program, proposals were received for the above-referenced project at the SARP10 Office on February 13, 2018. Five (5) qualified SSES firms submitted proposals for five (5) contract areas. Refer to the table below to see which contract areas firms submitted proposals on. The firms submitting proposals were: Ace Pipe Cleaning (ACE), ADS Environmental Services (ADS), Compliance Envirosystems (CES), TREKK Design Group (TREKK), and W&T Contracting Corporation (W&T).

The total footage for the five areas is approximately 1,891,600 linear feet and included both localized tributary areas as well as large-diameter interceptor assessment.

In conjunction with the Program Management procurement guidelines, the proposals were evaluated through the following criteria: Project Approach and Schedule, Project Team and Experience, M/WBE Participation, and Cost of Scope of Work. A selection committee was established for the review and evaluation of these proposals and was monitored by Bobby Allen, Hal Humphrey and Phillip Hannan.




Figure 1: Sewer Assessment & Rehabilitation Program Phase 6 Areas
