**Request for Qualifications For**

Black & Veatch and Overland Contracting (a subsidiary of Black & Veatch), as the Program Manager and Construction Manager for the Sewer Assessment and Rehabilitation Program (SARP10) on behalf of the City of Memphis, is soliciting Statement of Qualifications (SOQ) for the **General Engineering & Field Services**. These services are expected to be for two years in duration, with specific services procured and negotiated on a task order basis determined by hourly billing rates.

Some of the services provided may include, but are not limited to:

1. Pipeline planning & design services
2. Lift station planning & design services
3. Surveying & easement services
4. Materials testing
5. Erosion prevention & sediment control inspections

**Registration:**

Firms not already prequalified with SARP10 and Firms that prequalified more than one year ago, must submit the following registration information before award of any future work. This is not required to submit a SOQ. SARP10 registration is valid for one year from the date of approval and will apply for all related contracts, under the SARP10 Program. If the Firm has prequalified with SARP10 in the past year, the Firm is not obligated to reapply.

- **Step Two:** A Black & Veatch Sourcing Specialist will send a separate email requesting additional information for review and approval by Black & Veatch / OCI.

**Statements of Qualifications:**

Statements of Qualifications will be received at the SARP10 Program office 845 Crossover Lane, Suite 120, Memphis, TN 38117 until **3:00 P.M. (local time), October 19, 2017**. Late SOQ's will be rejected and will not be considered for award. Additional instructions for submitting the Statement of Qualifications are included in the RFSOQ.

A non-mandatory project information meeting will be held at the Benjamin L. Hooks Central Library at 1:30 P.M. on September 21, 2017.
