In conjunction with the City's Consent Decree Sewer Assessment and Rehabilitation Program, proposals were received for the above-referenced project at the SARP10 Office on December 13, 2016. Six SSES firms submitted proposals for the four projects. The firms submitting included: Compliance EnviroSystems (CES), Cambridge Construction Management (CCM), ADS Environmental Services, Trekk, Synergetic Engineering Solutions, and Champion Cleaning Services (CCSI).

The total footage for the four areas is approximately 1,261,000 linear feet and included both localized tributary areas as well as large-diameter interceptor assessment.

In conjunction with the Program Management procurement guidelines, the proposals were evaluated through the following criteria: Project Approach, Project Team and Experience, M/WBE Participation, and Cost. A selection committee was established for the review and evaluation of these proposals and was monitored by Bobby Allen, Brad Davis, and Bently Green.

The results of the proposals are as follows:

Note that the overall MWBE goal established with the Office of Contract Compliance is 21%.


