In conjunction with the City’s Consent Decree Sewer Assessment and Rehabilitation Program, proposals were received for the above-referenced project at the SARP10 Office on May 7, 2024. Three (3) qualified SSES firms submitted proposals for two (2) contract areas. Refer to the table below for which contract areas each firm submitted proposals on. The firms submitting proposals were as follows: Compliance EnviroSystems (CES), Hydromax USA (HUSA), and W&T Contracting Corporation (W&T).

The total footage for the two areas is approximately 380,000 linear feet and included both localized tributary areas as well as large-diameter interceptor assessment.

In conjunction with the Program Management procurement guidelines, the proposals were evaluated through the following criteria: Project Approach and Schedule, Project Team and Experience, M/WBE Participation, and Cost of Scope of Work. A selection committee led by Josh Grabowski was established for the review and evaluation of these proposals and was monitored by Christopher Morrical and Jerry Caldwell. The table below provides a summary of the cost portion of this evaluation.
