**Q2:** Will the Owner please provide minimum thicknesses for the 24-in and 27-in diameter CIPP, or should the Contractor just follow the ASTM F1216 design guidelines?

**SARP10:** The contractor shall comply with ASTM F1216, adhering to the design specification requirements outlined in Section 02535, Part 2 – Products, Subsection 2.07 – Design.

**Q3:** Since safety is of the Owner's utmost concern, will the Owner please consider adding an allowance item for site security/safety on this project?

**SARP10:** There is currently no allowance added. Site security is solely on the contractors needs and preference.

**Q4:** Will the Owner please provide the diameters and lengths of the following segments? (referencing sheets D4, C6, and D6)

**SARP10:** All pipes for the segment shown on the map are included in the bid schedule. Some pipes may have been temporarily hidden due to an applied filter; however, removing the filter will reveal all relevant information.
